IT HAS BEEN DECIDED TO HOLD XVI AP STATEMEET IN AIR, SMALL BORE AND SHOTGUN EVENTS FROM 16TH AUG TO 21ST AT SHOOTING RANGES GACHIBOWLI, HYD.

THOSE COMPETITORS WHO WANT TO PARTICIPATE IN THESE COMPETITIONS ARE REQUESTED TO GO THROUGH THE FOLLOWING INSTRUCTIONS CAREFULLY FOR THEIR OWN CONVENIENCE AND TO ENSURE SMOOTH AND SUCCESSFUL CONDUCT OF THE ABOVE COMPETITIONS.

ELIGIBILITY

1. ALL MEMBERS OF RAAP/DISTRICT ASSOCIATIONS.
2. PARTICIPANTS USING THEIR OWN ARMS SHOULD BE IN POSSESSION OF VALID ARMS LICENSE.
3. JUNIORS CAN TAKE PART IN .22 RIFLE / PISTOL / SHOTGUN EVENTS UNDER THE SUPERVISION OF LICENSE HOLDERS.
4. SUB-JR CAN TAKE PART IN ONE AGE CATEGORY ONLY I.E EITHER IN JUNIORS OR IN SR.CATEGORY.
5. ALL THE MATCHES WILL BE CONDUCTED AS PER NR RULE.

IMPORTANT

1. ONLY THREE SHOOTERS WILL BE ALLOWED TO USE COMMON WEAPON. THE NAMES OF SHOOTERS LIKELY TO USE COMMON WEAPON SHOULD BE INTIMATED TOGETHER WITH THE WEAPON NUMBER TO THE ORGANIZING SECRETARY IN ADVANCE ENABLING TO WORK OUT THE DETAILS FOR THE CONDUCT OF THE RELEVANT MATCHES.
2. THE RIFLE ASSOCIATION OF ANDHRA PRADESH RESERVES THE RIGHT TO AMEND THE RULES AT ANY TIME AT ITS SOLE DISCRETION. ORGANIZING COMMITTEE'S DECISION WILL BE FINAL AND BINDING.
3. RAAP HAS THE RIGHT TO CLOSE ANY MATCH OR EVENT IN CASE OF UNAVOIDABLE CIRCUMSTANCES OR OTHERWISE WITHOUT ASSIGNING ANY REASON.
4. ALL PARTICIPANTS COMPETING IN JUNIORS/SUB-JR EVENTS WHO WILL BE COMPLETING 21 YRS AND 14 YRS RESPECTIVELY AS ON 31.12.15 ARE REQUIRED TO PRODUCE A COPY OF AGE PROFF CERTIFICATE ISSUED FROM APPOROPRITE AUTHORITIES.THE CERTIFICATE MUST BE ATTACHED ALONG WITH THEIR ENTRY FORMS.
5. MATCHES WILL COMMENCE FROM 9.00 A.M, SHOOTERS ARE REQUESTED TO BE PRESENT AT THE FIRING POINT BEFORE 20 MINUTES.
6. CHANGE IN MATCHES IS NOT ALLOWED ONCE THE ENTRY IS SUBMITTED.
7. PRIZES WILL BE AWARDED ONLY TO THE M.Q.S SHOOTERS.I.E 60 % IN RESPECTIVE EVENTS.
8. IN ANY EVENT IF THE NO. OF PARTICIPANTS ARE THREE, PRIZES WILL BE AWARDED TO ONLY TWO SHOOTERS.
9. THE OFFICIAL PRACTISE WILL BE HELD AS PER THE ATTACHED SCHEDULE.
10. ALL PARTICIPANTS MUST BE IN POSSESSION OF COMPETITOR CARD WHICH WILL BE ISSUED TO THEM AT THE VENUE.
11. ANY SHOOTER VIOLATING THE SAFETY RULES WILL BE DISQUALIFIED.
12. FEE ONCE PAID IS NOT TRANSFERABLE OR REFUNDED.
13. SHOOTERS TAKING PART IN PEEP SIGHT RIFLE MATCHES ARE NOT ALLOWED TO TAKE PART IN OPEN SIGHT RIFLE MATCHES OR VICE-VERSA.
